18.83 Matters Arising

- Vandalism to cricket club including the screens, bottom half of screens damaged in the
 last month. Humbleton Recreation club to ensure details are forwarded to the Police on
 timely basis.
- Potholes same areas prior to Manor Farm, plastic bollards near Manor Farm, potholes
 on Humbleton Road. Bollards removed from Flinton post box clerk to investigate.
 Recommending everyone report potholes. Clerk to provide Chair with Terry Weaver
 contact details as the issue of the ditches / dyke collapsing in Flinton near the bus shelter.
- Police reports theft of mobile phone on Long Lane noted in our area.
- Maintenance schedule ivy on bus shelters to be removed clerk to organise when it stops raining.
